## REGIONAL REPORT

Our RCM team gave their report this month; which is included in your minutes.

## BREAK WAS TAKEN FROM 1:50 pm to 2:00 pm.

After returning from break, the next order of business on the agenda was open forum discussion. Some of the highlights are as follows:

1. World & Regional budgets. This in reference how monies are being used at the World Service Organization and at our Regional level. Please GSR's refer to your notes.
2. Revisited last month's decision on which the GSR's voted on at January ASC, as the motion was a guideline change. By this being passed on the floor, 4 violations of our area guidelines were broken. The motion in January was a guideline change Please refer to the following in our area guidelines:

**Article VIII**, Section 1, subsection A: Motions changing Guidelines will go out in the May and October minutes of the ASC to the groups for their Conscience.

**Article VIII**, Section 5, subsection I: The prudent reserve will be set at \$1,000.00 (one-thousand dollars).

**Article VIII**, Section 5, subsection J: The Primary Purpose Area of Narcotics Anonymous will divide funds above prudent reserve between Regional and World Services, as stated in the Guide to Local Services, page 62 (For example, there is \$500 above prudent reserve; \$250 shall be sent to the Region and \$250 shall be sent World).

**Article XIV**, Section 1, subsection C: Allow GSR's to approve expenditures of funds less than or equal to \$50.00 for any one transaction. If the GSR's do not unanimously agree, then the motion must go back to the Home Groups. This motion does not supersede monies passed to the Region or World above prudent reserve.
