- ★ **Open Forum:** Per ASC Guidelines unless any addict in an executive committee position, including alternate positions notifies the ASC Chair or Vice Chair of needed absence, and misses 3 ASC meetings in a row will forfeit their position at which time nominations for that position will be open until the next ASC.

 - READS: To remove ASC PR subcommittee chairperson for non-compliance of guidelines - missing 3 consecutive subcommittee meetings, and not attending ASC.
 - INTENT: To return to the subcommittee
 - FINANCIAL IMPACT: None
 - Voted on the floor. GSR'S 9 yes, and 1 opposed to. PR chair position open for nomination

Position for PR Chair will remain open until May ASC- 2 nominations were submitted today.

Financial report for Spring Up and Dance has been submitted to ASC Treasurer and Secretary.

PR: Haven't had a Flier Day since 2015. Professional Correspondence letter was drafted to mail out to courts, P&P, and other H&I's. Sug made that we do this every other year. Letter to go out June 1st. Learning Days is Aug 10th in Chillicothe at Simpson Park from 12-6pm. Will confirm pavilion. Secretary will make flier to send to home groups, and web coordinator to add to our website once approved by subcommittee. **MCC:** representatives are at VIC training for prison. 1-2 panel members, met 7x, avg 10-25 addicts present. Topics: 3rd Step/Tradition, open discussion, Living Clean, group conscious, stick mtg. **MCJ:** 1-3 panel members; met 14x; 2-8 addicts present. Topics: Who is an addict, Living Clean. Needing another male to take a meeting into jail. Addict requested Baby Blues for Shelby Co. Jail to take a

meeting there. **Point of Order:** To remove current Chairperson for non-compliance of Guidelines. Addict will make motion in ASC.

PPACNA: We now have a PO Box in Macon. Secretary and Treasurer each have a key. Treasurer is working on bank account. Discussion of subcommittees having members. Motion made to have a debit card for checking account-passed. Motion made for only Treasurer and Chair to know PIN-passed. Motion made for PIN to change when Treasurer changes-passed.

RCM: Your RCM did attend the Regionals, and it went very well. The morning session we gathered in groups and worked on a piece of new literature that will be coming out. June 2019 is the cutoff date for New Literature "Spiritual Principle a Day" book project. A packet has been put in the Group Mailboxes.
