Greetings Family,

Your RCM team attended the Show-me Region July 15 & 16, 2023. First, we would like to thank the Activities Committee and members of the PPANA for a great hosting weekend. The resumes that were voted on by the groups all passed. The motion 20220415-1, concerning mileage was withdrawn. Now on to new business. There are 5 resumes to be voted on and also there were 6 motions, with 1 passing on the floor. In our report your groups will have to vote on 5 of the 6 motions.

Resumes: 1 resume for AD, 1 resume for Alt. Secretary, 1 resume for Literature Chair, 1 resume for SMRCNA Chair, 1 resume for Campvention Chair.

Motions read as follows:

Motion #20230716-01: To add to Guideline 6.2(b)(1) "following any RSC where a position listed on the bank account changes, names on the account must be added or removed by the account holder prior to the next RSC.

Intent: To stay accountable for NA funds.

Motion #20230716-02: (This was voted on in house-housekeeping issue) The motion reads as follows: To replace "October" with "July" in Policy 4.2a. Additionally to remove the last sentence and add "treasurer and Alternate Treasurer" to the list of officers in the first sentence. Intent: So that our previously approved guidelines reflect our practices. This motion passed on the floor.

Motion #20230716-03: Should we (the RSC body) add the required information to the FB account to enable the groups of the Show Me Region to make a future decision about whether or not to accept those funds. (Information includes: 501c3 org name, address, banking info, bank contact and bank logo)

Intent: To obtain a group conscience on this topic.

Motion #20230716-04: To add to the following to 5.8h-Assume the position of Chair upon completion of term as Vice Chair by a vote of confidence from the RSC.

Intent: To stay consistent with other Regional Alternate or Vice positions.

Motion #20230716-05: To change P and G (RSC Guidelines)-To extend the terms of RD and RDA to mirror the WSC cycle to 3-year commitments.

Intent: To follow the WSC cycle.

Motion #20230716-06: In Reg P and G 3.1L To remove "subcommittee members, GSR and Alternatives" Intent: To clean up guidelines.

Your RCM team will be collecting votes for the resumes and motion at the September ASC. Groups, please have your votes ready then. Attached to this report are all the resumes and motions.

The treasurer's report for the RSC is as follows: Balance in the checking account is \$6,020.72, prudent reserve is \$11,775.00 which puts the region at \$5,398.58 below prudent reserve.

Saturday business: There was a workshop about WSC presented by RD and AD. There was discussion concerning taking money from FB. (There is a motion concerning this topic)

Sunday business: Discussion on the floor to form an ad-hoc committee concerning dissolving the SMRCNA BOD. There is concern about the amount of planning it takes for a convention to be successful. The committee is looking for addicts to step up. Please discuss this at your homegroups. If you would like to volunteer show up at the regional meeting on Saturday to be a part of.

Next RSC will be October 14 & 15, 2023 and January 13 & 14, 2024. It is held at the Drury Plaza Hotel 3100 Interstate 70 Dr SE, Columbia MO.
